

# Asylum & Immigration

Information for people (adults) from abroad who have experienced human trafficking and/or exploitation, on your rights and support in Scotland.



## Have you experienced human trafficking or exploitation?

Being trafficked or exploited can have a long-term impact on you and affect many parts of your life. You may also find it difficult to adjust to living in a new country or place. But you are not alone. There is help for you to start recovering from your experiences and help you settle into your new life.

## ASYLUM

If you believe you will be at risk of serious harm if you return to your home country, you may need international protection. You can seek international protection in the UK by making a claim for asylum. By making a claim for asylum, you will be asking for permission to stay in the UK for your own safety as a Refugee or by being granted Humanitarian Protection.

Claiming asylum is a complicated process and you have the right to legal advice. It is very important that you have a solicitor to advise and help you with your asylum claim. It is very important that you get legal advice as soon as possible (see below for information on finding a solicitor).

## FAMILY REUNION

If you have been granted Refugee status or Humanitarian Protection you have the right to make an application to bring your spouse/unmarried partner and children under the age of 18 living abroad, to join you in the UK.

It is important to get legal advice and assistance in making an application for Family Reunion.

## EU/EEA CITIZENS

The UK left the European Union (EU) on 31 January 2020. This process is known as 'Brexit'. From 1 January 2021, the rights of EU nationals living in the UK have changed.

EU, EEA, or Swiss citizens and their family members who were living in the UK on 31 December 2020 and wanted to stay in Scotland/UK must have applied to the EU Settlement Scheme (EUSS) BEFORE 30 JUNE 2021, for either:

- ▶ **Settled Status (indefinite leave to remain); or**
- ▶ **Pre-Settled Status (limited leave to remain for 5 years)**

If you are an EU citizen or the family member of an EU citizen and did not apply to EUSS before the 30 June 2021 deadline, may not have the right to stay in the UK after 1 July 2021. If you want to continue to stay in Scotland/UK, you should get urgent legal advice (see below).

If you are an EU citizen who arrived in Scotland/UK after 1 January 2021 you cannot apply for Settled Status or Pre-Settled Status.

The rules and rights for EU citizens and their family members are complicated and you should get legal advice to understand your rights.

## IMMIGRATION STATUS/RESIDENCE PERMIT

You may need to renew your immigration status/residence permit or get advice on the conditions of your permission to stay in the UK. A solicitor can help you with this.

## LEGAL ADVICE

If you have an issue with any of the areas mentioned in this factsheet, it is very important that you get legal advice from the right solicitor (lawyer) for your legal needs. This will depend on what sort of case you have.

If you cannot afford to pay for a solicitor, you may be eligible for legal aid. Legal aid is available regardless of your immigration status. Legal aid in Scotland is provided by the Scottish Legal Aid Board. You can check the Scottish Legal Aid Board website ([www.slabb.org.uk/](http://www.slabb.org.uk/)) to see if you can get legal aid, before contacting a solicitor.
